Chairman Glen Kack called this regular meeting of the Yellow Medicine County Board to order at 9:00 a.m. with Commissioners Ron Antony, Mitch Kling, Greg Renneke and John Berends also present. Also present were County Administrator Angie Steinbach and HR Manager Ashley Soine.

Approve Agenda 11-28-23-01 Motion by Commissioner Antony and seconded by Commissioner Kling to approve the agenda. Motion carried with all voting in favor.

Consent Agenda 11-28-23-02 Motion by Commissioner Berends and seconded by Commissioner Renneke to approve the consent agenda items as follows: November 14, 2023 County Board meeting minutes; Crisis Transportation Agreement with Avera Granite Falls; hiring of Jake Erickson as a Deputy Assessor/Appraiser, his salary will be grade 12, step 4, his start date is December 18, 2023; Crossing Surface Installation Agreement with BNSF Railway. Motion carried with all voting in favor. 2024 Salary for Non-union Employees 11-28-23-22 Motion by Commissioner Antony and seconded by Commissioner Berends to approve a 3.5% cost of living adjustment in 2024 for non-union employees. Motion carried with all voting in favor.

Resolution #50-2023 for 2024 Commissioner Per Diem 11-28-23-23 Motion by Commissioner Antony and seconded by Commissioner Berends to approve Resolution #50-2023 which sets the 2024 per diems paid to Commissioners for other meetings attended at a maximum of \$200/day (no change from 2023). Motion carried with all voting in favor.

Resolution #51-2023 and 2024 Salary for Commissioners 11-28-23-24 Motion by Commissioner Antony and seconded by Commissioner Berends to approve a 0% COLA for Commissioners and Resolution #51-2023 which establishes 2024 compensation amounts for Yellow Medicine County Commissioners. Commissioner salary will be \$25,603 annually and the Chairperson will receive \$26,803 annually (\$1,200 more than base Commissioner salary). Motion carried with Commissioner Antony, Berends and Kack voting in favor and Commissioner Renneke and Kling voting against.

Resolution #52-2023 and 2024 Salary for Attorney 11-28-23-25 Motion by Commissioner Berends and seconded by Commissioner Kling to approve Resolution #52-2023 which establishes 2024 compensation amounts for Yellow Medicine County Attorney. Attorney salary will be \$133,322.25 annually. Motion carried with all voting in favor.

2024 Salary for Sheriff 11-28-23-26 Motion by Commissioner Renneke to approve the 2024 salary for the Sheriff at \$134,849.88. Motion failed due to lack of a second.

Resolution #53-2023 and 2024 Salary for Sheriff 11-28-23-27 Motion by Commissioner Berends and seconded by Commissioner Antony to approve Resolution #53-2023 which establishes 2024 compensation amounts for Yellow Medicine County Sheriff. Sheriff salary will be \$127,305 annually. Motion carried with all voting in favor.
