Approve Agenda 03-28-23-01 Motion by Commissioner Kling and seconded by Commissioner Berends to approve the agenda with the following change: remove demolition quote for tax forfeited property from Regular Agenda. Motion carried with all voting in favor.

Consent Agenda 03-28-23-02 Motion by Commissioner Antony and seconded by Commissioner Kling to approve the consent agenda items as follows: March 14, 2023 County Board meeting minutes; advertise three seasonal positions (2 Highway and 1 Parks); Enterprise Lease Quote for Maintenance Department; hiring of Matt Miguel as a full-time Assistant Custodian, his salary will be grade 4, step 2, his start date is TBD.
